

End-of-Sale Notification for S-Series Modular Switch Family and TAA models of the SSA Switch Family

October 29, 2018

This End of Sale notification is intended to announce the End of Sale for S-Series Switches on April 30, 2019.

The Extreme Networks S-Series family of flow-based switches was GA in 2009 to bring high-performance distributed switching to the access, distribution, campus and data center network. Consisting of 8, 6, 4, 3 and 1 slot chassis options, as well as a fixed configuration S-Series Standalone (SSA), the family offers more than 9.5 Tbps backplane capacity and some of the highest switching port densities per rack in the market.

Note that while the TAA models of SSA switches are included in this EOS notice, the non-TAA models are not included
